

TRAINING FIELD – TRAINING ROOM RULES OF USE / WAIVER

- A waiver / vaccine record must be on file prior to facility use. The waiver may be printed from this site, then signed, and mailed or dropped off at the office.
- Management must approve each handler before independent facility use may be scheduled.
- Scheduling of facilities use shall be done on line, using our web calendar.
- Once handlers are approved, they will be issued a password to allow for scheduling.
- Handler(s) must have received formal training on agility equipment or have achieved a Novice level agility title before independent use of agility equipment.
- Use of either facility is limited to personal practice or play. The facility may not be rented to hold a training class for any individual or group unless prior arrangements are made with Creature Comforts' management.
- Handlers are responsible for moving any equipment as needed, and for storing equipment in the designated area when done. The A-Frame and Dog Walk are not to be moved.
- Any damage of equipment must be reported to the office.
- Handlers are responsible for cleaning up after their dogs – on field, paths, driveway, yards, or inside the training room.
- Any harsh or abusive treatment of animals solely as determined by Creature Comforts management shall result in immediate and permanent barring of the handler from future use of the facility.
- Fees for use of the field or training room shall be set at \$5.00 per hour, per person. Fees may be dropped off at the Creature Comforts office or placed in the drop box near the office door after business hours.
